7. Discussion and possible action to evaluate the performance of the Webb County Elections Administrator, who is subject to the authority of the Webb County Election Commission. The commission may take any appropriate disciplinary action deemed necessary to implement its decision, including termination and/or the appointment of an interim administrator if necessary; and any other matters incident thereto.

The Webb County Elections Commission hereby reserves the right to go into closed session at any time during this public meeting, if such is requested by the County Attorney or other legal counsel for the County, pursuant to his or her duty under Section 551.071(2) of the Government Code, to consult privately with his or her client on an item on the agenda, or on a matter arising out of such item.
