

## Notice About 2024 Tax Rates

Property tax rates in WEBB COUNTY.

This notice concerns the 2024 property tax rates for WEBB COUNTY. This notice provides information about two tax rates used in adopting the current tax year's tax rate. The no-new-revenue tax rate would impose the same amount of taxes as last year if you compare properties taxed in both years. In most cases, the voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. The rates are given per \$100 of property value.

<b>This year's no-new-revenue tax rate</b>	\$0.392794/\$100
<b>This year's voter-approval tax rate</b>	\$0.508293/\$100

### Voter-Approval Tax Rate Adjustments

#### State Criminal Justice Mandate

The WEBB COUNTY Auditor certifies that WEBB COUNTY has spent \$516,502 in the previous 12 months for the maintenance and operations cost of keeping inmates sentenced to the Texas Department of Criminal Justice. WEBB COUNTY Sheriff has provided WEBB COUNTY information on these costs, minus the state revenues received for reimbursement of such costs. This increased the voter-approval tax rate by 0.000497/\$100.

#### Indigent Health Care Compensation Expenditures

The WEBB COUNTY spent \$1,276,780 from July 1, 2023 to June 30, 2024 on enhanced indigent health care at the increased minimum eligibility standards, less the amount of state assistance. For the current tax year, the amount of increase above last year's enhanced indigent health care expenditures is \$588,778. This increased the voter-approval tax rate by 0.001900/\$100.

This notice contains a summary of actual no-new-revenue and voter-approval calculations as certified by Patricia A. Barrera, Webb County Tax Assessor Collector on 08/09/2024.
